IJA Membership Application

___ **Regular Membership** is defined as any individual proprietorship, partnership, corporation or other enterprise, engaged primarily in the selling of jewelry at retail to consumers from a permanent, commercial retail location. Temporary structures such as mall booths or kiosks where total primary business is not fine retail jewelry sales, do not meet the requirement for membership. We hereby make application for joint membership as Regular Members in the Illinois Jewelers Association and in the Jewelers of America, Inc. **We are sending in photos of the outside of our retail store and the inside of our retail store to verify our permanent commercial location.**

___ **Associate Membership** is defined as suppliers, vendors, designers or other related businesses within the jewelry industry. (This is for membership to the Illinois Jewelers Association only. Associate members must join Jewelers of America separately.)

___ **Student Membership** is defined as any person currently enrolled in a college, university or vocational program which provides jewelry industry accreditation in courses, such as, selling of jewelry, precious and semi-precious stones, watches, clocks, silverware, precious and semi-precious metalware, and the repair of such items.

___ **Retired Membership** is defined as any person retired from the retail selling of jewelry.

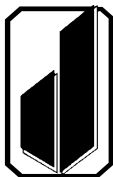
